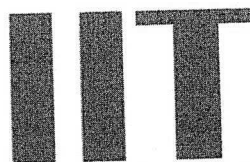

Subject:- A. Exemption of Income Tax on donations made to IIT(BHU) under the provisions contained in the following sections of the Income Tax Act, 1961.

(i) u/s 80G(2)(a)(iiif) IIT(BHU).

(ii) Clause (ii) of sub-section (i) of section 35.

B. Exemption from the operation of the provisions of the Foreign Contribution (Regulation) Act [FCRA].

Dear Sir/Madam,

It is hereby notified that the Institute has been granted following exemptions on donations:-

- (i) Under Section 80G(2)(a)(iiif) by the Chief Commissioner of Income Tax (Exemption), New Delhi vide notification no. CCIT(E)/Order u/s 80G(2)(a)(iiif)/IIT(BHU)/2016-17/176 dt. 19.04.2016.
- (ii) Under Clause (ii) of sub-section (i) of section 35 of the Income Tax Act, 1961 by Ministry of Finance (Central Board of Direct Taxes), New Delhi vide notification no. 22/2015 dated 13th March, 2015.
- (iii) As per letter no. II/21022/73(0002)13-FC-II-FCRA-II of the Under Secretary, Government of India, Ministry of Home Affairs, New Delhi, the Institute is exempted from the operation of the provisions of the Foreign Contribution (Regulation) Act [FCRA], in term of this Ministry's Gazette Notification S.O. 1492 (E) dated 01.07.2011.
