In some situations, it becomes difficult for the Institute to provide further details/clarifications of the announced/communicated facts.

It is once again reiterated that such communication to press media/electronic media should be strictly refrained by all the faculty, non-faculty members and by the students of the Institute without fail. Also the instructions issued vide aforementioned notices should be strictly adhered to.
