## NOTICE

## Subject: Compliance with GFR Rule 149 for Procurement of Goods and Services -Reg.

This is to inform you that the Deputy Chief Executive Office (DCEO), Government e-Marketplace (GeM) vide his letter dated 04.06.2025 had provided a list of Bids (31 bids), which had been published outside GeM to procure goods & services during FY 24-25 by the bidders/tenderers of IIT(BHU) & had informed about the contravention of the GFR Rule 149. The letter was discussed in the meeting held on 04.07.2025 under the Chairmanship of the Director with the concerned buyers/tenderers of the Institute, alongwith the reasons for procurement outside GeM, which has led to non-compliance with the provision of Rule 149 of the General Financial Rule.

In this regard, as per the decision taken for compliance of Rule 149 of the GFR, all buyers of the Institute are advised to procure items through GeM only through catalogue mode. In the event of non-availability of goods and services on GeM, such items may be procured through GeM Custom Bidding/GeM BOQ Bidding, as the case of may be. Further, if the item could still not be procured, then the proposal be sent for approval of the Director for initiating procurement outside GeM, alongwith documents to support the attempts/efforts made to procure the item from GeM.

This issues with the approval of the Competent Authority.
