Subject: Implementation of New Group Insurance Coverage Plan

In reference to notice no. IIT(BHU)/Recovery/GI/2024-25/539 dated 17-01-2025, this is to inform all concerned faculty and staff who joined the Institute after 31-08-2013, that the existing Group Insurance Plan with LIC of India will expire on 10-07-2025.

This is also to inform that on the recommendations of the Committee and its approval of the Competent Authority, the SBI Life Insurance Company Limited has been selected as the new Group Insurance provider, effective from 11-07-2025. The details of Sum Insured Amount and Premium are as follows:

Group	Sum Insured	Monthly Premium (inclusive of GST)
Group - 'A' (Faculty & Officers)	₹1,00,00,000/-	₹1,396/-
Group - 'B & C' (Employees)	₹50,00,000/-	₹698/-

The above Group Insurance cover will also be applicable to all the faculty and non-faculty staff, who have opted for the said scheme, in response to the Institute email dated 22-05-2025, in addition to the existing GSLI Scheme.

Furthermore, the premium for the first two months will be deducted from the salary of July-2025, and thereafter, the premium will be deducted from the salary of employees on a monthly basis.

This is issued with the approval of the Competent Authority.

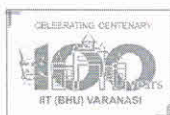

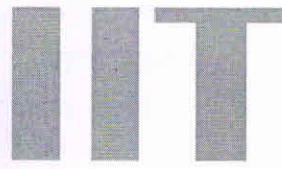
