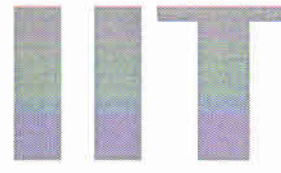

Subject: Revision of Monthly Premium under the Group Insurance Coverage Plan

In continuation of Notice No. IIT(BHU)/Recovery/GI/2025-26/5157 dated 10-07-2025, this is to inform to all concerned faculty and staff that SBI Life Insurance Company Limited has revised the monthly premium rates for the Group Insurance Coverage Plan for the policy period 11-07-2026 to 10-07-2027.

As the revised premium rates have now been finalized, the differential amount of premium, wherever applicable, will be adjusted in the salary for July-2026. Thereafter, the monthly Group Insurance premium will be deducted at the revised rates with effect from the subsequent salary cycle.

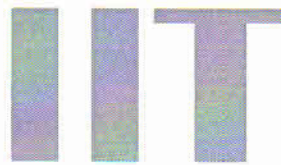
