- 4. The Scholarship shall be continued in the subsequent semesters only on the condition that he/she scores a minimum of 7.25 SPI.
- 5. In addition to above a sum of Rs. 25,000/- shall be awarded as a Cash Award to a meritorious student based on his/her CPI at the end of 5th Semester. The student's performance in projects/internship may also to taken into account while deciding the
