- Note: 1) The Mess Advance Charge mandatory for all students (hosteller) through the fee portal link mentioned as above. Those students who will pay their academic fee through the loan are required to fill the Google form. Those students who will pay their academic fee through Bihar Credit Card Scheme are mandatory to pay their academic fee at the fee portal only, later they will submit the application for the refund through the proper channel in the office of the Dean (Academic Affairs).
 - PLEASE NOTE THAT THE FEE IS TO BE DEPOSITED ONLY THROUGH THE FEE PORTAL. THE INSTITUTE SHALL NOT BE RESPONSIBLE, IF A STUDENT DEPOSITS MESS FEE! ACADEMIC FEE DIRECTLY IN ANY ACCOUNT OF THE INSTITUTE.
 - 2) The conditions for the payment of Zero credit registration fee is as follows:
 - (a) who on semester leave due to employment, maternity leave etc. of the PG Student (M.Tech./M.Pharm./M.Sc./Ph.D.) is on any leave other than permitted under Clause 6 of PG Ordinance at the time of registration as specified in the academic calendar with the period of leave extending to full semester, shall register for zero credit and shall pay of Rs. 5700/- for the **Zero Credit Registration Fee**.
 - (b) Similarly, if any student of UGD/IDD is on semester leave/semester drop at the time of registration shall also register for zero credit. Such students shall not be entitled to facilities like hostel, medical, laboratory and campus services. They will also not attend any class. He/she shall pay Rs. 700/- for the **Zero Credit Registration Fee**.
 - (c) All Ph.D. scholars who, if getting Institute Assistantship after submission of Ph.D. thesis at the beginning of Semester, shall register for Zero Credit and shall pay of Rs. 5700/- for the **Zero Credit Registration Fee**.
 - If a PhD scholar submits his/her thesis during the semester then he/she may register himself/herself for zero credit for the remaining period of that semester without paying any zero credit registration fees.

Payment of fees within the stipulated date does not amount to the registration of a student. For registration, he/she will have to complete online registration formality and send e-receipt of the bank to his/her Department/School by mail on or before 1st January, 2026.

Students unable to complete online registration formality on the date of commencement of semester & registration (i.e., 1st January 2026 as the case may be) will be permitted to register only after payment of fine @ Rs. 500.00 per day for each day of late reporting.
