Payment of fees within the stipulated date does not complete the registration of a student. For registration, he/she will have to complete online course registration formality and send e-receipt of the bank to his/her Department/School by mail on or before 18<sup>th</sup> April, 2022.

Students unable to complete online registration formality on the date of commencement of semester & registration (i.e., 18<sup>th</sup> April 2022) may be permitted to register only after payment of fine @ Rs. 500.00 per day till 22<sup>nd</sup> April, 2022.
